One of the most important was negotiated in 1945, when Stalin signed the Sino-Soviet Friendship Treaty with Chiang Kai-shek and the Chinese Nationalists, that included a secret protocol granting the Soviet Navy sea control over the Manchurian littorals. This secret protocol excluded the US Navy from landing Nationalist troops at the major Manchurian ports, thereby guaranteeing the Chinese Communist victory in Northeast China; from Manchuria, the Chinese Communists quickly spread south to take all of Mainland China. To a large degree, therefore, this formerly undiscussed secret diplomacy set the underlying conditions for the Cold War in East Asia.


