

African political thought: an intellectual history of the quest for freedom / Stephen Chan. - London: Hurst & Company, 2021. 262p.



Abstract: African liberation is often seen in terms of heroism, but seldom in terms of thought. Even Sartre, in his preface to Frantz Fanon's seminal *The Wretched of the Earth*, wrote of the 'native' with his coiled muscles about to explode into rebellion. The African and the black person are denied the condition of philosophy, apparently driven only by frustration and anger. Stephen Chan's new book charts the long history of African political thought, from the years of North American slavery, through the development of modern African nationalism and the difficulties of governing new states, to Africa's political philosophy today, taking on the world as an equal. He dwells at length on major figures from Marcus Garvey and Kwame Nkrumah's postcolonial generation to Biko, Mandela and Ellen Johnson Sirleaf. He shows their leadership to be inseparable from their ideas, and from those of literary giants including Fanon, W.E.B. Du Boi.



Abstract: The first panoramic history of the Western world from the 1970s to the present day, *Empire of Democracy* is the story for those asking how we got to where we are. Half a century ago, at the height of the Cold War and amidst a world economic crisis, the Western democracies were forced to undergo a profound transformation. Against what some saw as a full-scale "crisis of democracy"-- with race riots, anti-Vietnam marches and a wave of worker discontent sowing crisis from one nation to the next-- a new political-economic order was devised and the postwar social contract was torn up and written anew. In this epic narrative of the events that have shaped our own times, Simon Reid-Henry shows how liberal democracy, and western history with it, was profoundly reimagined when the postwar Golden Age ended. As the institutions of liberal rule were reinvented, a new generation of politicians emerged: Thatcher, Reagan, Mitterrand, Kohl. The late twentieth century heyday they oversaw carried the Western democracies triumphantly to victory in the Cold War and into the economic boom of the 1990s. But equally it led them into the fiasco of Iraq, to the high drama of the financial crisis in 2007/8, and ultimately to the anti-liberal surge of our own times.







Abstract: Developing an original theoretical approach to understanding the roots of regional conflict and cooperation, *International Relations in the Middle East* explores domestic and international foreign policy dynamics for an accessible insight into how and why Middle Eastern regional order has changed over time. Highlighting interactions between foreign policy trajectories in a range of states including Egypt, Iran, Iraq, Israel, Saudi Arabia, Syria and Turkey, Ewan Stein identifies two main drivers of foreign policy and alignments: competitive support-seeking and ideological externalisation. Clearly linking political, ideological and foreign policy dynamics, Stein demonstrates how the sources of regional antagonisms and solidarities are to be found not in the geopolitical chessboard, but in the hegemonic strategies of the region's pivotal powers. Making the case for historical sociology - in particular the work of Antonio Gramsci and Louis Althusser - as the most powerful lens through which to understand regional politics in the Middle East, with wider implications for the study of regional order elsewhere.



Abstract: This book examines how the rise of China has influenced its cross-regional foreign policy toward non-Arab countries in the Middle East between 2001 and 2011. Analyzing contemporary international crises in the Middle East such as the Iran nuclear crisis, the Palestinian–Israeli conflict, and the Cyprus question, the volume draws on daily newspapers published in Chinese, Turkish, and English and official documents as primary sources. The examined period is critical to understand China’s aggressive and more attractive foreign policy dynamism in the following years. All the bilateral relations China has developed in the Middle East during these years was a preparation for the next big step toward China’s rising influence in the region and the world. 

Abstract: How is foreign policy made in Iraq? Based on dozens of interviews with senior officials and politicians, this book provides a clear analysis of the development of domestic Iraqi politics since 2003. Zana Gulmohamad explains how the federal government of Iraq and Kurdistan Regional Government (KRG) have functioned and worked together since toppling Saddam to reveal in granular detail the complexity of their foreign policy making. The book shows that the ruling elites and political factions in Baghdad and in the capital of the Kurdistan Region, Erbil, create foreign policies according to their agendas. The formulation and implementation of the two governments' foreign policies is to a great extent uncoordinated. Yet Zana Gulmohamad places this incoherent model of foreign policy making in the context of the country's fragmented political and social context and explains how Iraq's neighbouring countries - Iran, Turkey, Saudi Arabia and Syria before the civil war - have each influenced its internal affairs. The book is the first study dedicated to the contemporary dynamics of the Iraqi state - outside the usual focus on the "great powers" - and it explains exactly how Iraqi foreign policy is managed alongside the country's economic and security interests.



Abstract: This ground-breaking book offers an extensive legal analysis grounded in public, EU, and international law of arms trade regulation, integrated with insights drawn from international relations. Intimately connected with sustaining repressive governments and violations of international human rights and humanitarian law, arms exports are also a central element in the economic and strategic policies of the governments of all large industrial states. They have also been the source of abundant corruption, and of serious challenges to the norms and effectiveness of constitutional accountability in democratic states. 





The Brezhnev that emerges is a complex one, from his early apolitical years, when he dreamed of becoming an actor, through his swift and surprising rise through the Party ranks. 

Abstract: The India-Pakistan dispute over Kashmir is one of the world's incendiary conflicts. 





Abstract: Waziristan, a region on the border between Afghanistan and Pakistan, has in recent years become a flash point in the so-called 'War on Terror'. Hugh Beattie looks at the history of this region, examining British attempts to manage the tribes from 1849 until Pakistan's declaration of independence in 1947. He explores British attempts to divide the frontier region into separate British and Afghan spheres of influence. In the minds of British policymakers, this demarcation would secure the position of the Empire, and so Beattie highlights the various policy initiatives towards the frontier region over the period in question. Crucially, he analyses how the British perceived the local tribes, what constituted authority within tribal frameworks, and the military and political ramifications of these perceptions. As he also explores the contemporary relevance of this region, taking into account the resurgence of the Taliban in Waziristan, Beattie's analysis is vital for those interested in the history and security implications of the Afghan frontier with Pakistan.





It looks at this relation through the lens of trauma for the mind, biopolitics for the body and visibility for the body politic. This interpretive frame helps examine how the 9/11 violence created a moment where the mind, body and body politic could be redefined after 9/11. In an important theoretical intervention into 21st-century American Studies, it asks what the relation between the state and those it expels from its citizenry is. It makes a special mention of sites of incarceration such as Guantanamo Bay and Abu Ghraib as 9/11 phenomena.
